



**Influenza Reagent
Influenza Infectious Virus NIBRG-301

1. INTENDED USE

The influenza reference virus NIBRG-301 is a reassortant prepared by reverse genetics from A/duck/Vietnam/NCVD-1584/2012 (H5N1) virus (in which the polybasic HA cleavage site has been excised) and A/PR/8/34 (H1N1) virus. The known passage history of 14/246 is attached.

2. CAUTION

This preparation is not for administration to humans or animals in the human food chain.

The material is not of human or bovine origin. As with all materials of biological origin, this preparation should be regarded as potentially hazardous to health. It should be handled only in appropriate containment facilities by fully trained and competent staff in accordance with your national as well as international safety guidelines. 4. CONTENTS

Country of origin of biological material: United Kingdom.
Each ampoule contains 250µl (nominal) of infectious influenza virus as allantoic fluid from embryonated hen's eggs.

5. STORAGE

Store in the dark at -70°C or below

Please note: because of the inherent stability of lyophilized material, NIBSC may ship these materials at ambient temperature.

6. DIRECTIONS FOR OPENING

Vials have a screw cap; an internal stopper may also be present. The cap should be removed by turning anti-clockwise. Care should be taken to prevent loss of the contents. Please note: If a stopper is present on removal of the cap, the stopper should remain in the vial or be removed with the cap.

7. USE OF MATERIAL

A range of dilutions (e.g. 10⁻³ to 10⁻⁵) should be made in a suitable medium for initial cultivation.

8. STABILITY

Reference Materials should be stored on receipt as indicated on the label.
