Low Molecular Weight Urokinase

This material is not for in vitro diagnostic use.

1. INTENDED USE

This preparation is a reagent for enzyme activity assays involving low molecular weight urokinase.

2. CAUTION

This preparation is not for administration to humans or animals in the human food chain.

The preparation contains material of human origin, and either the final product or the source materials, from which it is derived, have been tested and found negative for HBsAg, anti-HIV and HCV RNA. As with all materials of biological origin, this preparation should be regarded as potentially hazardous to health. It should be used and discarded according to your own laboratory's safety procedures. Such safety procedures should include the wearing of protective gloves and avoiding the generation of aerosols. Care should be exercised in opening ampoules or vials, to avoid cuts.

3. UNITAGE

This preparation has no formally defined unitage but in chromogenic activity assays it has been found to have 22 % of the activity of the WHO 2nd International Standard for High Molecular Weight Urokinase, 87/594. However, these results may vary with the precise assay conditions.

4. CONTENTS

Country of origin of biological material: United Kingdom.


5. STORAGE

On receipt, ampoules should be stored in the dark at -20 °C. Activity is stable for short periods at ambient temperatures, for example during shipping.

Please note: because of the inherent stability of lyophilized material, NIBSC may ship these materials at ambient temperature.

6. DIRECTIONS FOR OPENING

Tap the ampoule gently to collect the material at the bottom (labelled) end. Ensure ampoule is scored all round at the narrow part of the neck, with a diamond or tungsten carbide tipped glass knife file or other suitable implement before attempting to open. Place the ampoule in the ampoule opener, positioning the score at position 'A'; shown in the diagram below. Surround the ampoule with cloth or layers of tissue paper. Grip the ampoule and holder in the hand and squeeze at point 'B'. The ampoule will snap open. Take care to avoid cuts and projectile glass fragments that enter eyes. Take care that no material is lost from the ampoule and that no glass falls into the ampoule.

7. USE OF MATERIAL

No attempt should be made to weigh out any portion of the freeze-dried material prior to reconstitution

Before opening, ampoules should be allowed to equilibrate to room temperature. The contents of the ampoule should be reconstituted with 1 ml of distilled water and the solution stored on ice and used within 5 hours. Stability of this solution over longer times, or of frozen aliquots, should be investigated by the user.

8. STABILITY

Reference materials are held at NIBSC within assured, temperature-controlled storage facilities. Reference Materials should be stored on receipt as indicated on the label.

NIBSC follows the policy of WHO with respect to its reference materials

No information is available on the long term stability of the standard for low molecular weight urokinase.
